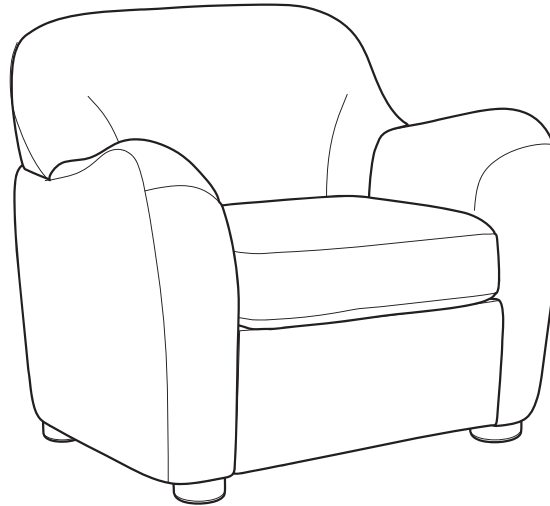

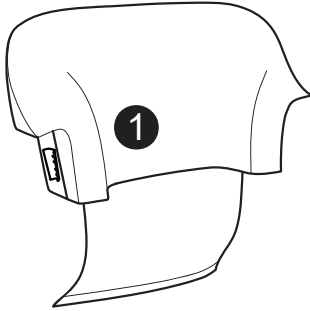
- Please DO NOT dispose packaging material till you are satisfied with the finished product.

- To remove unwanted wrinkles, steam the covers before placing the cushions inside. Steam the inside of the cover on low heat (110F). DO NOT iron the fabric on the side with pile.
- Seat cushions may take 3-4 days to fully expand, which will allow wrinkles and indentations caused by packing to fade.
